

MANDATORY DISCLOSURE CHECKLIST

It is mandated by the Florida Supreme Court that each party in any family law proceeding produce the documents listed below to the other party at the beginning of the case. The court also imposes a duty upon each party to supplement these disclosures and to update or amend their financial affidavit when the information changes for any reason.

As your attorney, I am charged with insuring that you comply with these requirements by the deadlines, as thoroughly and accurately as possible. This can be accomplished much more efficiently and far more economically if you provide me with a complete copy of the documentation requested. Copies of all documentation provided should be neatly arranged in the proper order as set forth in the Request provided to you, and items such as cancelled checks, credit card statements, etc. should also be arranged neatly in chronological order. This will save you unnecessary expenses for having to sort out and identify the documents in order to prepare your disclosure documents.

If any of the documentation is not available to you or is in the possession of your spouse, you must indicate that on this form. For example, many times one spouse will maintain the checking account statements. However, that does not mean that you are unable to produce them, if you have online access to the account, or are authorized to request them from your bank, you must do so. Examples of when you may not have access to documentation include accounts where you are not named as an owner or signor, preventing you from having the information released to you from the institution directly.

1. FINANCIAL AFFIDAVIT. (*This form is included with your packet*)
